



**VENDOR CONTRACT FOR SUMMER 2017 AT THE MONONGAHELA AQUATORIUM**

This contract is between Aquatorium Innovations, Inc. (a Pennsylvania non-profit corporation whose primary office is located at 142 West Main Street in Monongahela, PA) and \_\_\_\_\_ (herein referred to as "vendor") to permit vendor to sell food products at the Monongahela Aquatorium located in Monongahela, PA during events sponsored by Aquatorium Innovations, Inc.

By signing the contract below, Vendor recognizes that the following information constitutes the requirements of becoming a vendor, and also agrees to abide by all Aquatorium rules.

- Each vendor space comprises a 10' X 10' space to be determined by Aquatorium Innovations, Inc.
- Vendor must provide his/her own table(s) or booth and chair(s).
- The vendor contract fee of \$50 per event includes admission of no more than three vendor representatives. Vendor area setup must occur an hour *before* gates open on any event day.
- Vehicles must be moved after unpacking.
- Vendor may not sell any illegal substances of any kind
- Aquatorium Innovations, Inc. reserves the right to reject vendor applications.
- All food vendors must provide proof of insurance and current ServSafe certification (or equivalent)
- **NO BEVERAGES or WATER** may be sold by vendors. Aquatorium Innovations has the exclusive right to beverage sales.
- Vendors selling novelty items such as popcorn and shaved ice will be given a price in accordance with the product they are selling. The starting price is \$10.00 per week and will be determined by the Aquatorium Committee.
